All horses must be exercised and shown by their owners, a member of the owner's immediate family (mother, father, spouse, son, daughter, brother, sister), or by someone else – none of whom may regularly receive remuneration for showing a horse or training a horse for horse show purposes. Further, anyone working for or with a professional and receiving regular remuneration will not be considered an amateur. Individuals in question will be considered on the merits of each case by the Board of Directors; all complaints to be taken in writing if possible.
  3. Judge and/or Ringmaster reserves the right to excuse any horse or exhibitor who may cause a danger in the class.
  4. The Show Committee shall have the right to refuse any entry.
- \*\*5. ALL EXHIBITORS Under 19, WHILE MOUNTED, RIDING OR DRIVING HORSES OR BIKES ON THE SHOW GROUNDS MUST WEAR AN ASTM, SEI CERTIFIED HELMET. THIS IS A HARFORD COUNTY RULE. NO EXCEPTIONS!**
6. ABSOLUTELY NO DRIVING OF MOTORIZED GOLF CARTS OR ANY MOTORIZED VEHICLE BY UNLICENSED INDIVIDUALS.
